



重要事項

1. 請於**三個月內**使用現有櫃員機密碼於自動櫃員機或易辦事進行一次交易以啟動新卡。否則新卡將於三個月後失效。目前持有的自動櫃員機卡將於新卡啟動後失效。

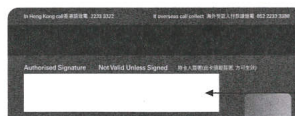
Important notes

4. If you wish to use PLUS/Cirrus network ATM services, you can do so by linking your bank accounts to your Visa/MasterCard credit card (where applicable).
